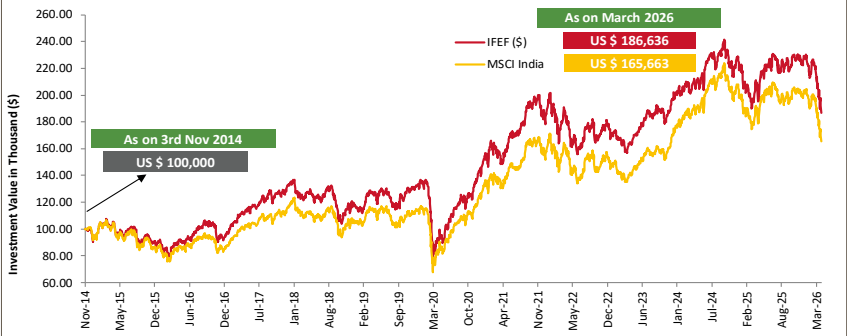

- Escalating Middle East tensions triggered an oil shock & VIX spike, driving global de-risking & worsening India's macro outlook; Major energy supply disruption (>10%) sent oil prices sharply higher: +56.7% in Mar'26 (after +2.5% in Feb'26); Brent now at \$113.6/bbl
- With ~90% crude import dependence, India faces strong macro headwinds; JPM cut CY26 GDP to 6% (-50 bps) & raised FY27 inflation to 4.6%
- Govt. earmarked \$6.2 bn to cushion the economy from global spillovers; Govt. cut excise duty by Rs. 10/litre on petrol and diesel to cap pump prices; Implies ~Rs. 1.75 Tn (~0.5% of GDP) annual revenue loss, straining the FY27 fiscal deficit target (4.3% of GDP)
- 10-year G-Sec yields averaged 6.75% in Mar'26 (Feb'26: 6.70%); Month-end yield rose 38 bps MoM to 7.04%
- INR depreciated 4.1% MoM to 94.83/USD (1 Yr depreciation: 9.9%)
- India's FX reserves fell to \$698 Bn (20 Mar), implying ~\$25.3 Bn RBI intervention over 4 weeks
- SEBI signaled tighter, data-driven oversight of equity derivatives speculation, especially short-tenor index options
- India's Defence Acquisition Council approved Rs. 2.38 Tn (~\$25 Bn) of purchases
- HDFC Bank Chairman resigned from the board citing differences over values and ethics
- Kotak Mahindra Bank reported no material balance sheet impact from the alleged Rs. 1.6 Bn (~\$16.9 Mn) fixed-deposit fraud linked to Panchkula Municipal Corporation; Emerged as the preferred buyer for Deutsche Bank's India retail business (~Rs. 45 Bn deal)
- Zomato raised its platform fee to Rs. 14.9 from Rs. 12.5, per in-app updates; Eternal infused Rs. 4.5 Bn into Blinkit amid intensifying competition in the 10-minute delivery space
- MakeMyTrip is evaluating a listing of its Indian unit to improve capital access & strengthen its domestic brand; Vedanta will demerge into 5 listed entities next month, a step its founder believes could more than double its ~\$27 Bn market cap

The past month saw the Iran-Israel-US tensions peaking and culminating in heavy air strikes across Middle East, impacting Oil prices across the world and with the Strait of Hormuz closed, prices remain elevated. MSCI India saw a sharp drawdown in Mar'26, with MSCI India (US\$) down 14.5%, underperforming MSCI APxJ and MSCI EM by 2.3% and 2.2% respectively, while MSCI India (INR) fell 11.3% over the month. Indian equities were pressured by a global risk-off move tied to escalating Middle East tensions and the resulting oil shock, which worsened India's macro backdrop, alongside INR weakness, record FII outflows, and concerns that higher inflation and input costs could compress corporate margins. Large caps declined 11.5%, underperforming Small and Mid caps by 1.4%/0.9%, and the Nifty 50 fell 11.3% to 22,331. Sector performance was broadly negative, with all sectors ending Mar'26 in the red. The steepest underperformance came from Real Estate (-20.1%), Financials (-18.9%), and Industrials (-17.3%), which led the market's drawdown for the month.

India faces two primary channels of impact from rising tensions in the Middle East: oil prices and remittances. India's dependency on imported crude oil is ~90%, and crude is its largest import. Any sharp increase in oil prices would primarily hurt the trade balance and widen the current account deficit. On a static basis, every \$10 per barrel increase in oil prices widens the current account balance by ~0.5% of GDP. The impact on the current account would be significantly larger if remittances from the Middle East to India also come under pressure. India receives ~38% of its remittances from the Middle East, with FY26 remittances estimated at 3.4% of GDP. If oil stays elevated, pressure is likely in consumer discretionary, airlines, chemicals, cement, and logistics, where higher fuel costs and FX pass through feed imported inflation and squeeze margins. Conversely, potential beneficiaries include upstream energy and coal linked names, as well as select refiners — provided crack spreads remain supportive and domestic pricing frameworks permit margin pass through.

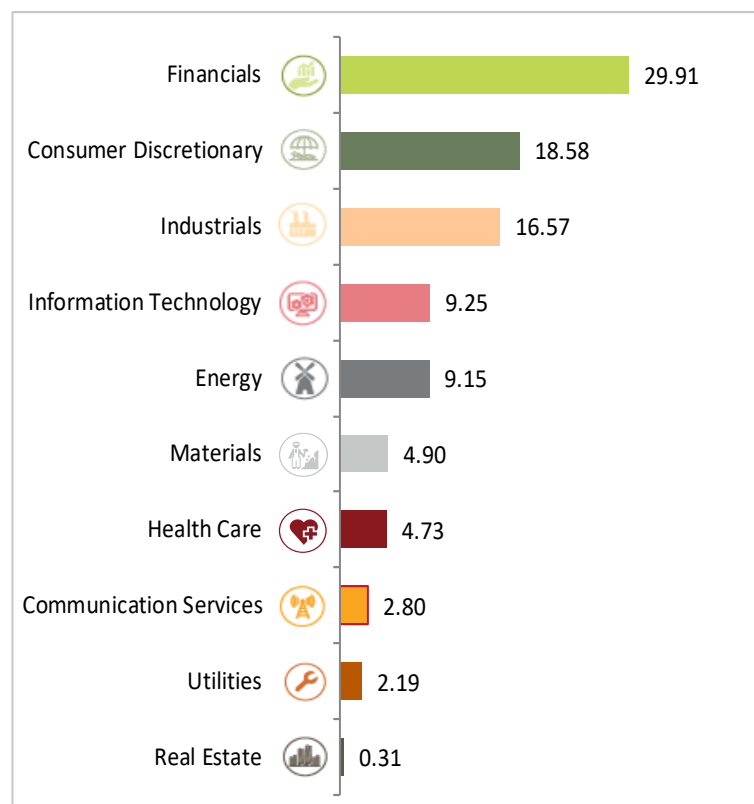

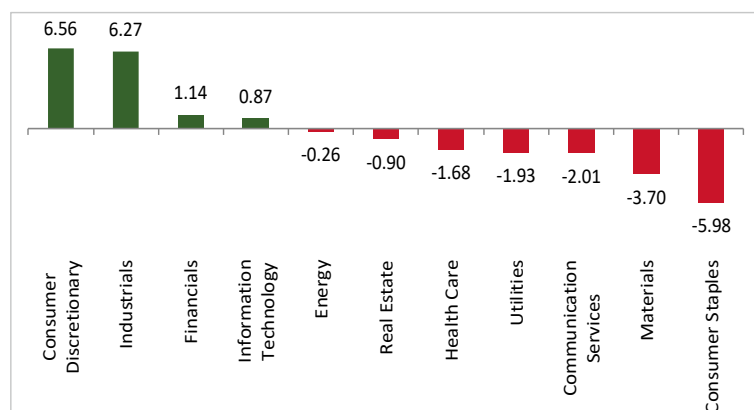
Sector Allocation (as on March 2026)

The above industry classification follows GICS Sector Classification. Portfolio details and attribution as of March 2026. Attribution analysis for 1 Year data. Data in percentage (%).

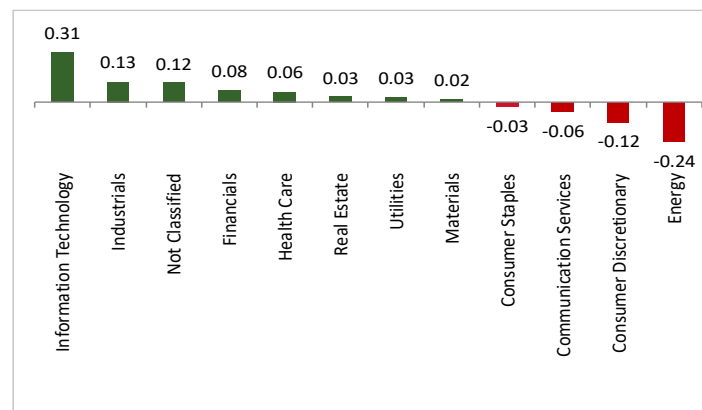
